#### VILLAGE OF CANWOOD

#### THIS AGREEMENT WITNESSETH as follows:

(a) The Highway 55 Waste Management Corporation, a duly incorporated corporation to operate a landfill within the boundaries of the Rural Municipality of Canwood No. 494.

### (b) <u>Capital Contribution Breakdown:</u>

- (1) The Rural Municipality of Canwood No. 494 agrees to contribute 60% of the capital cost of this facility.
- (2) The Village of Debden agrees to contribute 20% of the capital cost of this facility.
- (3) The Village of Canwood agrees to contribute 20% of the capital cost of this facility.

## (c) Initial Operation and Maintenance Costs Contribution Breakdown:

- (1) The Rural Municipality of Canwood No. 494 agrees to contribute 60% of the initial operation and maintenance costs of this facility.
- (2) The Village of Debden agrees to contribute 20% of the initial operation and maintenance costs of this facility.
- (3) The Village of Canwood agrees to contribute 20% of the initial operation and maintenance costs of this facility.

- (e) Board members shall consist of two members representing each municipality appointed annually in January of each and every year.
- (f) It is understood and agreed that this Agreement shall be continuous.
