Special Appointment: 7:30 p.m., Ron Ferster & Bruce Harper, Hospital Fundraising Committee. They met with council to discuss the request that the hospital levy be left on the taxes in the Village of Canwood for at least 2013, but preferably until the hospital is fully paid for. Some other information presented:

- Original contributors for the levy were: R.M. and Town of Shellbrook, R.M. and Village of Canwood, Village of Debden, R.M. and Village of Leask, Village of Marcelin and the Hutterite Colonies (2)

- They are short approximately \$1.5 million to fully fund the construction
- Our share of total project cost is approximately \$5.8 million
- The breakdown of support (contributions from levy) for the construction by municipality is as follows:
 - \circ R.M. of Canwood 17%
 - \circ R.M. of Leask 11%
 - \circ R.M. of Shellbrook 21%
 - \circ Village of Canwood 5%
 - \circ Village of Leask 5%
 - \circ Village of Marcelin 2%
 - \circ Village of Debden 5%
 - \circ Town of Shellbrook 32%
 - \circ Emerald Lake 1%
- The levies from above were \$150 per household in all cases EXCEPT for the R.M. and Town of Shellbrook, who levied \$300 per household due to the Nursing Home Construction
- The R.M. of Canwood has committed to leaving the levy in place for another year
- The R.M. of Shellbrook, Town of Shellbrook have committed to leaving the levy in place until the project is fully funded
- Nothing has been received from the First Nation Communities at this time

150-12 **Thompson** - That the Council for the Village of Canwood holds a public meeting on January 10, 2013 at 7:30 p.m. in the Canwood Senior's Room to get the public's opinion on the request to leave the Hospital Levy on the Property Taxes beyond 2012.

Special Appointment: Darrel Nordquist. Darrel came to discuss his operation of a towing business in the former Young's Garage Building. He would like to build a compound area for short term storage on the lots beside and to the rear of the building. He has expressed that the fence will be 6' high and he will close in the fence with tarps so that contents are not visible and that he will not be doing any auto-wrecking or salvage out of this compound.

- Special Appointment: Ron Jonasson. Ron Jonasson is purchasing a lot in the Village and would like to put a park model trailer on this lot. The issue is that it is not considered an allowable building as per the building code/building inspector. However he would like the council to grant him permission anyway. We will look into the matter and discuss it further in January
- Special Appointment: Dale Schwehr, Bus Fundraising Committee. The Fundraising Committee has raised enough to purchase the bus, however, they would like to continue raising money so that user's do not have to pay a high fee to go on outings. They are projecting that the fuel costs for the bus will be approx. \$1,000 per year and are asking the Village if they would donate the fuel for the year, with the amount capped at \$1,000.

151-12 Piprell	- That the Council for the Village of Canwood agrees to grant permission to Darrel Nordquist to construct fenced area beside and to the rear of his business (as per the zoning bylaw) and to use such fenced area as a short term compound for temporary storage of vehicles. Temporary storage being defined as 60 days per vehicle. All impounded/temporarily stored vehicles must be stored within the fenced compound. The fence on the compound area must be 6' high and completely enclosed. Tarps will be allowed for enclosure on the side and back and board will be required on the front, made up of treated plywood, which must be painted and maintained. Absolutely no auto wrecking/salvage of vehicles will be allowed at this site.
152-12 Wiwcharuk	- That the Council for the Village of Canwood provides a grant for \$1000.00 to the Canwood Bus Fundraising Committee for use for fuel for the Handi-Bus purchased for the 2013 year. A request will have to be made annually for further funding. Carried
