Request for tender for demolition, clean-up and leveling of the remaining portion the Curling Rink building on Public Reserve R, Plan Y3516, Extension 0, 790 Main Street, Canwood, SK.

Tender bid price shall be required to include demolition of the remaining portion of the Canwood Curling Rink with the exception of the ice plant building, demolition of the remaining footings, cleanup with disposal of all materials to a landfill that is acceptable to the regional/provincial regulations and site leveling. The work must be performed in a manor that protects water and sewer utility connections, adjacent buildings, roads and parking lot infrastructure.

The successful tender must also include all considerations as listed below. Please attach documentation providing answers to the following:

- 1) Estimated start and finish time. (Work shall start at a mutually agreed-upon time and shall be completed within the time specified);
- 2) Equipment and method to be used to complete the tasks listed above as well including the removal of small debris such nails;
- 3) Assurance that site and excavation shall be secured at all times for the health and safety of the public including the hours when work is not being completed;
- 4) Proof of Contractors' Public Liability Insurance in the amount of \$2,000,000.00 to cover any occurrence of bodily injury, death, property damage;
- 5) Proof of Statutory Workers' Compensation Board coverage/certificate as required by law;
- 6) Acknowledgement that the contractor shall be responsible for adherence to initiating, maintaining and supervising all health and safety regulations, precautions and programs in connection with the work to ensure:
 - a) no person, property, right, easement or privilege is injured, damaged or infringed by reason of the contractor's activities in performance of the contract;
 - b) pedestrian and other traffic on any public or private road is not endangered by the method or means of its performance; and
 - c) the health and safety of all persons employed in the performance of the work is not endangered by the method or means of its performance.
