

VILLAGE OF CANWOOD

BYLAW NO. 1/99

A Bylaw of the Village of Canwood respecting the licensing, regulating and controlling of persons carrying on or engaging in certain businesses or callings within the Village of Canwood.

---

Pursuant to the provisions of the "Urban Municipality Act 1994" the Council of the Village of Canwood in open meeting assembled hereby enacts as follows:

This Bylaw may be cited as the General License Bylaw of 1999

INTERPRETATION: In this Bylaw

- a) "person" means and includes an individual or a group of two or more individuals or a Corporation carrying on business in the Village of Canwood who is not assessable for purposes of Business Tax within the Village.
  - b) "Village" shall mean the Village of Canwood
1. No person shall for gain carry on within the Village of Canwood any of the businesses, industries, callings, or occupations defined in this Bylaw without first having obtained a license to do so from the Village, and every person who is licensed shall be subject to the provisions of this bylaw.
  2. Every person who is subject to this Bylaw shall display in a conspicuous place in his office or recognized place of business, his annual license or receipt;

Persons required to be licensed under the provisions of this bylaw are those persons carrying on any businesses, industries, callings or occupations defined in this section who are not assessable for business tax purposes in respect to the business so carried on; and licenses issued to them shall be subject to compliance with the conditions, if any set out under the subsections of this section as hereinafter stated:

- A. CONTRACTOR: every person who carries on a business in the Village as contractor, jobbing contractor, building contractor, municipal contractor (whether for waterworks, sewage or otherwise) painter, cabinet maker, tinsmith, plumber, electrician, mason, bricklayer, plaster, decorator, sign painter or other trade relating to the building or construction industry.



PROVIDED HOWEVER, that a license issued under the provisions of this section shall not license the holder to move buildings which require a moving permit under the provisions of the Building Bylaw of the Village of Canwood.

- B. FUNERAL HOME: every person providing any services in respect to the embalming and preparing of deceased bodies, conveying deceased bodies, arranging for funeral services and generally carrying on any part of the business normally or usually carried on by a Funeral Home, or providing any services interregnum, provided that this section shall not apply to any person conducting only the interment in the Village of Canwood.
- C. HAIRDRESSER: every person carrying on the business of hairdressing or barbering.
- D. FOOD SERVICE: every person providing food for consumption by the public who is not assessed a business assessment in the Village.
- E. TRANSIENT TRADERS: every person who sells fruit, fish, produce and other food stuffs to the public.

Any person carrying on any business, industry, or calling that is not specifically provided for in this Bylaw shall be liable to a fee established by Village Council upon the Council determining the feature of the operation and relating it to others included in the Bylaw.

Any business, industry or calling licensed under the provisions of this Bylaw which is located in a residential district as provided in the Zoning Bylaw of the Village of Canwood shall not by way of a sign, outside storage or any other manner of use give any indication that the licenced operation is being carried out from that premises.

Every house, place or premises licensed under this Bylaw shall be liable to be inspected at all reasonable times by the Administrator, Medical Health Officer, Army Constable, Police Officer, or employee of the Village authorized in that behalf; and any person who shall refuse admittance to such officer or person after demand, shall be subject to the penalties of this Bylaw.

Every person required to be licensed under the provisions of this Bylaw shall apply for a license at the office of the Administrator in the Village Administration Building and pay the appropriate fee therefor as prescribed in Schedule "A" to this Bylaw.



All applicants for license shall state:

- 1 The name and address of the applicant
2. The nature of the license applied for:
3. The place where the proposed trade is exercised or where the same is to be carried on;
4. Such other information as required by the Administrator

All applicants for licenses shall upon application, deposit with the Village Administrator the amount of the license fee hereunder.

The Act of the spouse, servant, clerk or employee of any person licensed to carry on a business under this Bylaw pertaining to or in connection with the said business shall be deemed and be taken to be the act of the Licensee as though he had done the act himself.

Any person who carried on a business, industry or calling which is required to be licensed under this Bylaw without first having obtained a license to do so, carries on such business, industry or calling, shall be guilty of an infraction of this Bylaw.

Any person guilty of an infraction of any of the provisions of this Bylaw, shall, upon summary conviction be liable to a fine of not less than \$100.00 and not exceeding \$500.00 and costs; and in default of payment of the fine and costs the person convicted may be committed to jail or to a public lock up for any time determined by a Provincial Magistrate or Justice of the Peace not exceeding thirty (30) days, unless the penalty and costs are sooner paid.


In case of a conviction under the provisions of this Bylaw, the convicting justice shall order payment of the required license fee and compliance with any other provisions of the Bylaw, in addition to the penalty.


A person who fails within the period specified in an order to comply with the order is guilty of an offence and is liable on summary conviction to a fine of not less than \$5.00 or more than \$25.00 for each day during which the breach continues or to imprisonment for not less than one month or to both fine and imprisonment.

This Bylaw shall come into force on the final approval of Council
