
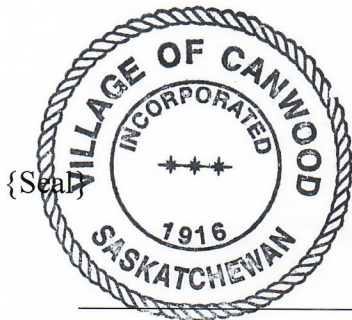


**BYLAW NO 2017 – 05
VILLAGE OF CANWOOD**

**A Bylaw to provide for entering into an agreement with the Canwood Regional
Park Authority for the provision of Fire Protection Services.**

The Council of the Village of Canwood, in the Province of Saskatchewan, enacts as follows:

1. The Village of Canwood is hereby authorized, on behalf of the Canwood Volunteer Fire Department, to enter into an agreement, attached hereto as Schedule "A" and forming part of this bylaw, with Canwood Regional Park Authority.
2. That the Mayor and Administrator are hereby authorized to sign and execute the attached agreement identified as Schedule "A".
3. The Village of Canwood shall provide administration services for the Canwood Volunteer Fire Department.
4. Canwood Volunteer Fire Department is located within the boundaries of the Village of Canwood.

SCHEDULE “A” to Bylaw No. 2017 – 05

Memorandum of Agreement Between:

Canwood Volunteer Fire Department
And
Canwood Regional Park Authority

This agreement witnesseth as follows:

WHEREAS, Canwood Volunteer Fire Department has been established and maintains a volunteer fire department for the provision of fire protection services;

AND WHEREAS, the Canwood Volunteer Fire Department is under the administration and control of the Rural Municipality of Canwood (60%) and the Village of Canwood (40%);


AND WHEREAS, Canwood Volunteer Fire Department is prepared to provide fire protection services to the Canwood Regional Park Authority, set out in Exhibit “A”;

AND WHEREAS, Canwood Regional Park Authority is desirous of the Canwood Volunteer Fire Department to provide fire protection services to all areas within the boundaries of the park as per the attached map known as Exhibit “A”;

AND WHEREAS, the Canwood Regional Park Authority understands that the Canwood Volunteer Fire Department is a volunteer based fire department and that call response is based on the availability of volunteers;

The parties to this agreement agree to the following terms and conditions:

1. Canwood Regional Park Authority agrees to accept any invoice for any fire call services provided by the Canwood Volunteer Fire Department.
2. It is understood and agreed that this agreement shall commence January 1, 2018, and be continuous. This agreement may be terminated by either party to the agreement by providing 90 days written notice.

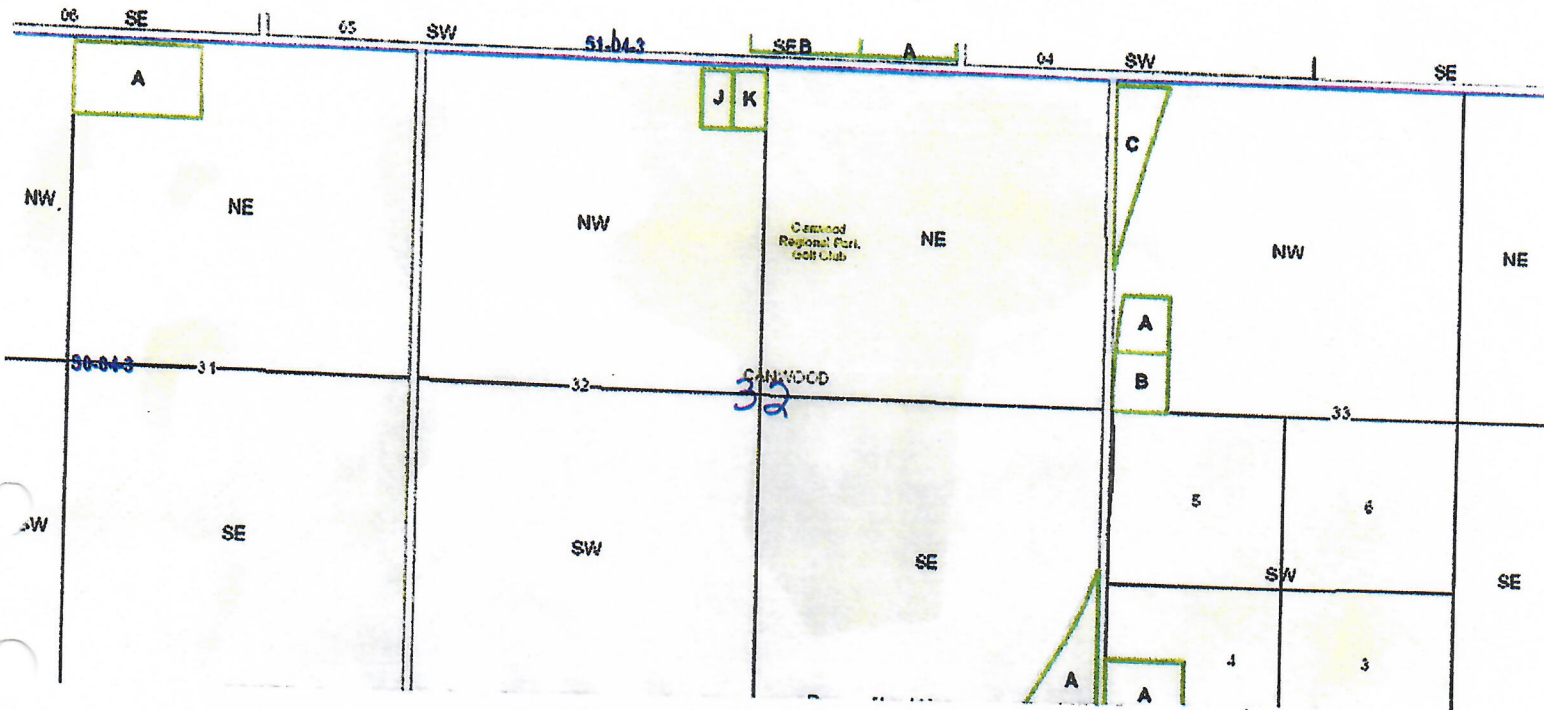
